## 2018 Fees & Payment Schedule

### CPC32813 Certificate III in Fire Protection – Apprenticeship Pathway

### Government Subsidised for NEW SOUTH WALES

---

#### Eligibility for a Government Subsidised Training

Fire Industry Training (FiT) is approved to deliver this training as an apprenticeship supported by NSW Smart and Skilled funding.

To be eligible, a person must be employed as an apprentice and the apprenticeship registered with Smart and Skilled NSW. For more information and to check eligibility for funded training refer to:

FiT will assist to determine eligibility prior to enrolment. Original documents will be required as evidence of identity and citizenship.

#### Course Fees

Course Fees are the actual contribution a student makes to the cost of their training, which may include fees for tuition, materials and amenities fees. Fees are calculated in accordance with the relevant funding authority requirements and will be advised to the apprentice prior to enrolment.

The student tuition fees as published are subject to change given individual circumstances at enrolment.

#### Fee Amounts

Under the NSW Government fee-free apprenticeship initiative, NSW apprentices commencing their training on or after 1<sup>st</sup> July 2018 may be eligible for fee-free training. For eligible apprentices neither the student or the employer pay for the qualification.

#### Materials Fee

Two payments of \$395 and \$535 for a total of \$910 per year will be invoiced at the commencement of each of the two semesters per year to cover the cost of learning materials and consumables.

---

#### Other costs

Other costs that may be incurred by the student would include, but are not limited to, the purchase of:

- Personal Protective Equipment
- Australian Standards
- Stationery (including pens, pencils, rulers, protractors, etc).

These costs are not charged by FiT. Students will be provided with a list of requirements prior to the commencement of training.

---

#### Student Fees – NOT eligible for funding

FiT only delivers this qualification to registered apprentices. An apprentice not eligible for a funded place will be charged the standard FiT Tuition and Material's Fees *plus* \$15 per nominal hour of the qualification (a detailed schedule of fees and charges can be requested from FiT). ### Recognition of Prior Learning (RPL) costs – Fee for service

### Terms and Conditions

FiT will take bookings for non-government subsidised qualifications and units of training. The following to be taken into consideration:

- An administration fee of \$50 will apply if the student fails to attend training
- Course dates and locations are subject to change
- Eligibility for subsidised rates is at the discretion of Fire Industry Training.

### Fees, Charges & Enrolment Status Changes Policy

FiT does not charge or accept more than \$1,500 for training yet to be delivered.

FiT reserves the right to cancel courses.

Refunds will only be issued on the following basis:

- FiT allows a student to cancel their enrolment with a full fee refund, if the cancellation is at least two weeks before the course commencement
- FiT will refund:
  - 50% of a student's fees if the student cancels between two and one week of their course starting
  - None of a student's fees will be refunded if the student cancels within one week or less of the scheduled course commencement date
  - Any variation to the policies is at the sole discretion of the Chief Executive Officer.
