CPC32820 Cert. III in Fire Protection – Apprenticeship Pathway

Government Subsidised for TASMANIA

Eligibility for a Government Subsidised Training Place

Fire Industry Training (FiT) is approved to deliver this training as an apprenticeship supported by Skills Tasmania funding.

To be eligible, a person must be employed as an apprentice and the apprenticeship registered with Skills Tasmania. For more information and to check eligibility for funded training refer to:

FiT will assist to determine eligibility prior to enrolment. Original documents will be required as evidence of identity and citizenship.

The fees presented are for the current year. For apprentices who commenced in previous years, make reference to fee statements reflective to the year of commencement; which can be provided upon request.

Course Fees

Course Fees are the actual contribution a student makes to the cost of their training, which may include fees for tuition, materials and amenities fees. Fees are calculated in accordance with the relevant funding authority requirements and will be advised to the apprentice prior to enrolment.

The student tuition fees as published are subject to change given individual circumstances at enrolment.

Fee Amounts

The following are typical fees based on a standard hourly rate per scheduled hour of enrolment and apply for training delivered with Tasmanian Government funding.

Individual Fees are calculated for each student once all information is known. Fees are invoiced after enrolment.

NOTE: Published Fees are subject to change given individual circumstances advised at enrolment.

If apprentice's academic progression falls outside of the normal three-year course structure, they will be provided with a personalised fee statement, prior to completion of the enrolment process. Apprentices with outstanding fees, may not be able to progress with their training blocks.

Materials Fee

Four payments per year settled prior to block training based on course hours will be charged to cover the cost of learning materials and consumables.

Other costs

Other costs that may be incurred by the student would include, but are not limited to, the purchase of:

- Personal Protective Equipment
- Australian Standards
- Stationery (including pens, pencils, rulers, protractors, etc).

These costs are not charged by FiT. Students will be provided with a list of requirements prior to the commencement of training.

2025 Fees & Payment Schedule - TASMANIA (CPC32820)

Student Fees – NOT eligible for funding

FiT only delivers this qualification to registered apprentices. An apprentice not eligible for a funded place will be charged the standard FiT Tuition and Material's Fees *plus* \$14.02 per nominal hour of the qualification (a detailed schedule of fees and charges can be requested from FiT). Terms and Conditions

FiT will take bookings for non-government subsidised qualifications and units of training. The following to be taken into consideration:

- An administration fee of \$50 will apply if the student fails to attend training

- Eligibility for subsidised rates is at the discretion of Fire Industry Training.

Fees, Charges & Enrolment Status Changes Policy

FiT does not charge or accept more than \$1,500 for training yet to be delivered.

FiT reserves the right to cancel courses.

Refunds will only be issued on the following basis:

- FiT allows a student to cancel their enrolment with a full fee refund, if the cancellation is at least two weeks before the course commencement.
- FiT will refund:
 - 50% of a student's fees if the student cancels between two and one week of their course starting
 - None of a student's fees will be refunded if the student cancels within one week or less of the scheduled course commencement date
 - Any variation to the policies is at the sole discretion of the Chief Executive Officer.
