## Fees, Charges & Enrolment Status Changes Policy

FiT does not charge or accept more than \$1,500 for training yet to be delivered. FIT reserves the right to cancel courses.

Refunds will only be issued on the following basis:

- FiT allows a student to cancel their enrolment with a full fee refund, if the cancellation is at least two
  weeks before the course commencement.
- FiT will refund:
  - 50% of a student's fees if the student cancels between two and one week of their course starting
  - none of a student's fees will be refunded if the student cancels within one week or less of the scheduled course commencement date
  - Any variation to the policies is at the sole discretion of the Chief Executive Officer.
