### UEE31020 Certificate III in Fire Protection Control – Apprenticeship Pathway

### Government Subsidised for WESTERN AUSTRALIA

#### Eligibility for Government Subsidised Training

Fire Industry Training (FiT) is approved to deliver this training as an apprenticeship supported by Jobs and Skills WA funding.

To be eligible for a government subsidy, a person must be employed as an apprentice and the qualification registered with the Department of Training and Workforce Development as suitable for apprenticeship delivery.

FiT will assist to determine eligibility prior to enrolment. Original documents will be required as evidence of identity and citizenship.

*The fees presented below are for the current year. For apprentices who commenced in previous years, course fees can be provided upon request.*

#### Course Fees

Course Fees are the actual contribution a student makes to the cost of their training, which may include fees for tuition, materials and amenities fees. Fees are calculated in accordance with the relevant funding authority requirements and will be advised to the apprentice prior to enrolment.

The student tuition fees as published are subject to change given individual circumstances at enrolment.

*PLEASE NOTE: the student tuition fees are indicative only and are subject to change given individual circumstances at enrolment. Additional fees may apply such as resource fees and other fees.*

#### Fee Amounts

The following are typical fees based on a standard hourly rate per scheduled hour of enrolment and apply for training delivered with Western Australian and Commonwealth Government funding. Four payments per year settled prior to block training based on course hours will be charged.

If apprentice's academic progression falls outside of the normal three-year course structure, they will be provided with a personalised fee statement, prior to completion of the enrolment process.

### Fee Exemptions

#### CONCESSIONS ON COURSES

Eligibility for the concession rate on course fees is determined at the time of enrolment.

The following students are entitled to the concession rate on course fees.

- Persons and dependants of persons holding:
  - A Pensioner Concession Card;
  - A Repatriation Health Benefits Card issued by the Department of Veterans' Affairs; or
  - A Health Care Card.
- Persons and dependants of persons in receipt of services from the following Commonwealth support or employment services programs:
  - Workforce Australia; or
  - Parent Pathways.
- Persons and dependants of persons in receipt of AUSTUDY or ABSTUDY.
- Persons and dependants of persons in receipt of the Youth Allowance.
- Persons and dependants of persons who are inmates of a custodial institution.
- Secondary school-aged persons, not enrolled at school.

If the concession is valid for the full enrolment period, then all eligible units the student enrolls in within that period attract the concession rate. If the concession is valid for part of the enrolment period, then only eligible units the student enrolls in on or after the start date and prior to the expiry of the concession attract the concession rate.

### Other costs

Other costs that may be incurred by the student would include, but are not limited to, the purchase of:

- Personal Protective Equipment
- Australian Standards
- Stationery (including pens, pencils, rulers, protractors, etc).

These costs are not charged by FiT. Students will be provided with a list of requirements prior to the commencement of training.

### Student Fees – NOT eligible for funding

FiT only delivers this qualification to registered apprentices. An apprentice not eligible for a funded place will be charged the standard FiT Tuition fee plus \$19.58 per nominal hour of the qualification (a detailed schedule of fees and charges can be requested from FiT). ### Terms and Conditions

FiT will take bookings for non-government subsidised qualifications and units of training. The following to be taken into consideration:

- An administration fee of \$50 will apply if the student fails to attend training
- Course dates and locations are subject to change
- Eligibility for subsidised rates is at the discretion of Fire Industry Training.

### Fees, Charges & Enrolment Status Changes Policy

FiT does not charge or accept more than \$1,500 for training yet to be delivered.

FiT reserves the right to cancel courses.

Refunds will only be issued on the following basis:

- FiT allows a student to cancel their enrolment with a full fee refund, if the cancellation is at least two weeks before the course commencement
- FiT will refund:
  - 50% of a student's fees if the student cancels between two and one week of their course starting
  - None of a student's fees will be refunded if the student cancels within one week or less of the scheduled course commencement date
  - Any variation to the policies is at the sole discretion of the Chief Executive Officer.
